Course Description: This Professional Development will allow teachers to meet Ohio's Highly Qualified Teacher criteria in a specific content area. - d. One complete lesson that bridges from the Extended Standards to Ohio New Learning Standards with the discipline you chose for HQT certification.
- e. Demonstrate the use of the Ohio Model Curriculum by using 2 websites listed within the units as a resource or part of activity.

8. All of the above must be submitted by deadline via a flash drive. The flash drive needs to be organized by folders.
